WAIVER of LIABILITY and HOLD HARMLESS AGREEMENT

In consideration of receiving permission to utilize the Common Areas at Countryside Marketplace shopping center, Menifee, California, as has been designated by prior agreement with Arts Council of Menifee and Retail Marketing Group/Rose Marinello, (hereinafter referred to as the "Premises") for which the 13th Annual Arts Council exhibition and public fair will be held in April 2025, I hereby release, waive, discharge and covenant not to sue Shin Yen Retail Property Management, Newport Property LLC, and all of Their officers, assigns, employees, contractors, agents (hereinafter referred to as "Releasees") from any and all liability, claim, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury (including death) that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Releasees or otherwise, while participating in such athletic, sales, leisure, patronage, vendor, exhibitor, purveyor of goods/services, etc. (hereinafter referred to as "Event") while in, on, or upon the above Premises where the event is scheduled to occur.

To the best of my knowledge, I am in good physical condition and am not aware of any physical infirmity which would place me at risk by participating in the Event. I voluntarily assume full responsibility for any risk of loss, property damage, or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged at these Premises for this Event, whether caused by the negligence of the Releasees or otherwise. I further hereby agree to indemnify and hold harmless the Releasees from any loss, liability, damage, or cost, including court costs and attorney's fees, that may be incurred due to my participation in said Event, and any subsequent incident or cause of action against any Releasee.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse if I am alive, and my heirs, assigns, and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue the above-named Releasees, I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of California. In signing this release, I acknowledge and represent that I have read and understand it and sign it voluntarily; that I am at least eighteen years of age and fully competent; I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
